## **Maintaining Our South County Commitment**

Thanks to the leadership of former chair and founding board member, Supervisor Don Gage, the Housing Trust of Santa Clara County has maintained an active presence in South Santa Clara County since our inception a decade ago. Today, we continue to create affordable housing opportunities throughout Santa Clara County through our homebuyer assistance loans, developer loans and homelessness prevention grants. See below to learn more about the Housing Trust's recent investment in South County.

#### **Homebuyer Assistance**

In the past year the Housing Trust has assisted 17 first-time homebuyers in South County, helping them get into new developments like Madrone Plaza in Morgan Hill. Craig and Wen Chi Capen recently moved into this development with the assistance of a Housing Trust CCAP loan. "The whole process went very smoothly" says Capen, "considering the current economy, getting into this home was a great accomplishment for us. Homeownership feels great!"

**Developer Loans for Affordable Rental Housing** In addition to directly helping home buyers, Housing Trust provided a \$500,000 developer loan to the Horizons at Morgan Hill project, a 49-unit senior housing development. Horizons is the first senior-targeted affordable housing community developed

in Morgan Hill, which has shown a growing need for senior housing. Steve Tate, Mayor of Morgan Hill and HTSCC board member commented recently that, "Morgan Hill is very proud of our record for providing high quality and very livable affordable housing throughout our beautiful community. We are able to leverage our Redevelopment Agency, our competitive Residential Development Control System and the fantastic support of partners like the Housing Trust to include below market rate units in all our developments as well as in totally affordable projects."

#### **Homelessness Prevention Assistance**

In 2010 the Housing Trust gave \$12,500 EHPG (Emergency Homelessness Prevention Grants) to South County Community Solutions' La Isla Pacifica Battered Women's Shelter and to St. Joseph's Family Center. "Thanks to the grant we received from The Housing Trust, Community Solutions was able to assist 15 women and their children in moving into stable housing after leaving our shelter, giving them the priceless opportunity to begin a new life free from violence and fear." Erin O'Brien, President & CEO of Community Solutions remarked. Community Solutions additionally received a Safety Net Capital Improvement grant (SNCI) of \$54,340 to make upgrades to two shelters, La Isla Pacifica and La Casa del Puente.

Congratulations to Housing Trust Executive Director, Kevin Zwick, on being selected to receive the 2010 Young Leaders Award by Affordable Housing Finance Magazine. He is one of only five recipients selected this year, and will be recognized for his contributions to the affordable housing industry nationally in the October issue of the magazine.



## **Housing Trust Partner Spotlight**
