Legislative Updates:

The CALIFORNIA HOMES AND JOBS ACT SB 391 (DeSaulnier) will:

- Create 29,000 jobs annually, primarily in the beleaguered construction sector.
- Help businesses attract and retain the talent that fuels California's economy.
- Generate an estimated \$500 million in state investment and leverage an additional \$2.78 billion in federal and local funding and bank loans to build affordable homes and create jobs.
- Deploy these dollars in California communities through a successful private/public partnership.
- Get California building again to create affordable home options for all Californians.

AB 532 (Rich Gordon, Menlo Park)

Another bill working its way through the state Assembly, AB 532 (Rich Gordon, Menlo Park) would allow local housing trusts throughout California to access existing funds to support, construct, and preserve affordable housing. The bill was unanimously passed by the Assembly Committee on Housing and Community Development. "Housing Trust Funds leverage public dollars from the state with new local funds, federal funds, and private contributions to increase the overall amount of funds for affordable housing, which is extremely critical in this time of reduced resources," said Kevin Zwick, Executive Director of Housing Trust Silicon Valley.
